The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: First Degree Burglary

Minnesota Statute: 609.582.1(a), with reference to: 609.582.1

Maximum Sentence: 20 years imprisonment, a \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/13/2023

Control #(ICR#): 23000626

Charge Description: On February 13, 2023, in Sibley County, defendant entered a dwelling without consent, when another person was inside the dwelling, and committed a crime while inside.

STATEMENT OF PROBABLE CAUSE

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court. Your Complainant is a peace officer employed by the Sibley County Sheriff's Office. In this capacity your Complainant believes the following to be true and correct.

On February 13, 2023, the Sibley County Sheriff's Office responded to a burglary that occurred in rural Henderson, Sibley County, State of Minnesota. An adult female reported that she was inside her residence when someone forcefully entered the attached garage and stole her vehicle. Law enforcement was able to track the vehicle using its On-Star application to Mystic Lake Casino. With the assistance of Mystic Lake security, law enforcement was able to locate and arrest Jesse Lee Nundahl (DOB 05-31-1978), hereafter referred to as "defendant." Mystic Lake Casino had video of defendant exiting the vehicle and he had the car keys on him at the time of arrest.

Law enforcement located shoe prints near the window of the garage from which the vehicle was stolen. The prints match the tread on defendant's shoes. Defendant stated to law enforcement, "I didn't think it was occupied" when he was told he was being charged with First Degree Burglary.

Defendant is currently being held in Scott County on local charges. A warrant is respectfully requested given the seriousness of the allegations.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

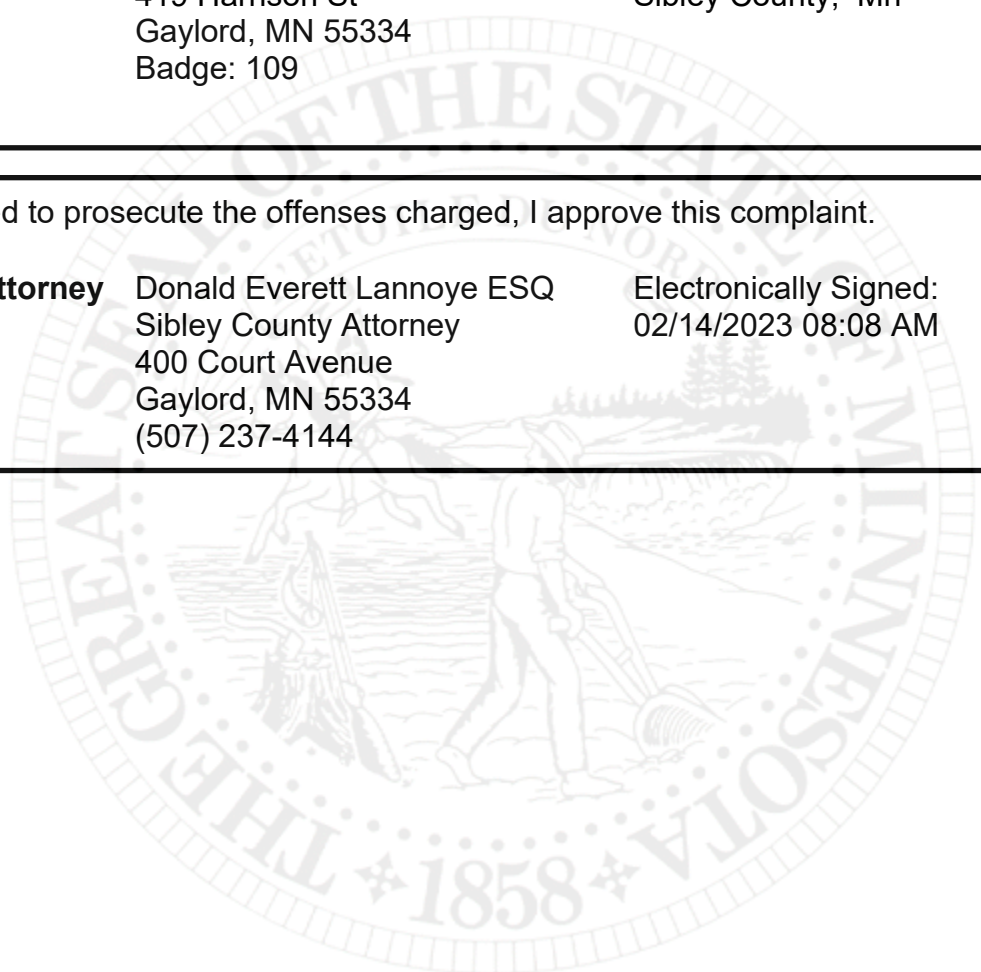
